In reference to Gazette notification dated 8th July, 2013 & its corrigendum for enhancement of annual intake capacity (one time increase as approved by the Ministry of Health and Family Welfare & Hon'ble Minister of Health & F.W.) in undergraduate courses in medical colleges for the academic year 2013-14, I am directed to convey the approval of the Board of Governors for the Increase in MBBS seats from 100 to 150 at KAP Viswanatham Govt. Medical College, Trichy under The Tamilnadu Dr. MGR Medical University, Chennai, Tamil Nadu with prospective effect i.e. from the academic year 2013-14 u/s 10A of the IMC Act, 1956, as amended.

This permission of the Board of Governors, Medical Council of India for increase of seats and admission of students against the increased intake is initially for a period of one year subject to renewal on annual basis in accordance with existing regulations of Medical Council of India.

In addition to above, this is further to inform you that while making admissions of your college to MBBS course it shall be ensured that:

- (i) No admission is permitted beyond the sanctioned intake capacity;
- (ii) Selection of Students to the Medical College is in accordance with the requirements laid down in the Graduate Medical Education Regulations, 1997;
- (iii) The admission process for the academic year 2013-14 has to be completed in accordance with the time schedule indicated in the Graduate Medical Education Regulation, 1997, as amended. No admission is permitted beyond the cut-off date.

It shall be incumbent upon the Medical College that the information relating to admissions should be submitted within a fortnight of closure of admissions to the Council. Any failure to submit the information within this time limit would be construed that the admissions in the College were not in accordance with the statutory requirements, thereby enabling the Council to proceed in accordance with law against the College and such admission would be liable to be cancelled.
